7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Trojan Technologies to upgrade the Trojan ultraviolet effluent disinfection system for**  
9 **Upper Tuscarawas Wastewater Treatment Plant 36, in Council District 8, as Best Practical**  
10 **Source, in an amount not to exceed \$29,424.04, for the Executive's Department of**  
11 **Environmental Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 28, 2012, awarded a  
14 purchase order with Trojan Technologies to upgrade the Trojan ultraviolet effluent disinfection  
15 system for Upper Tuscarawas Wastewater Treatment Plant 36, in Council District 8, as Best  
16 Practical Source, in an amount not to exceed \$29,424.04; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a purchase order with Trojan Technologies to  
27 upgrade the Trojan ultraviolet effluent disinfection system for Upper Tuscarawas Wastewater  
28 Treatment Plant 36, in Council District 8, as Best Practical Source, in an amount not to exceed  
29 \$29,424.04, is hereby confirmed and the County Executive is hereby authorized to execute such  
30 purchase order.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for the aforementioned system upgrade.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.

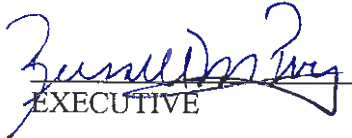
