7 **A Resolution authorizing the County Executive to advertise for bids for the Safety Building**  
8 **roof replacement project, in Council District 4, for an estimated total cost not to exceed**  
9 **\$167,000.00, for the Executive's Department of Administrative Services – Physical Plants,**  
10 **and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the Safety Building  
16 roof replacement project, in Council District 4, for an estimated total cost not to exceed  
17 \$167,000.00; and

19 WHEREAS, a copy of the specifications are on file in the office of the Clerk of Council;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
24 advertise for bids for the aforementioned project;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for the Safety Building roof  
32 replacement project, in Council District 4, for an estimated total cost not to exceed \$167,000.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
37 of the citizens of the County of Summit, and for the further reason that it authorizes the  
38 Executive to immediately advertise for bids for the Safety Building roof replacement project to  
39 permit the project to proceed as soon as possible.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.


