7 **A Resolution authorizing the County Executive to execute an agreement with Stark County**
8 **for the sale of a decontamination trailer and tow vehicle owned by the County of Summit,**
9 **for the amount of \$25,000.00, for Executive's Department of Law, Insurance and Risk**
10 **Management, Division of Public Safety/Emergency Management Agency, and declaring an**
11 **emergency.**

13 WHEREAS, the County of Summit owns a decontamination trailer and tow vehicle that
14 is no longer needed because the County purchased and placed into service a new vehicle and
15 trailer in 2011; and

16
17 WHEREAS, the County Executive has determined that the decontamination trailer and
18 tow vehicle has a fair market value in excess of \$15,000.00 and accordingly, the approval of
19 County Council is required to sell the same pursuant to Section 177.19 of the Codified
20 Ordinances of the County of Summit; and

22 WHEREAS, the County wishes to sell the decontamination trailer and tow vehicle to
23 Stark County for the amount of \$25,000.00; and

25 WHEREAS, pursuant to Section 177.07(a)(2) of the Codified Ordinances, contracts with
26 other governmental units is exempt from competitive bidding; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Executive to execute an agreement with Stark County for the sale of a decontamination trailer
31 and tow vehicle owned by the County of Summit, for the amount of \$25,000.00;

33 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of
34 Summit, State of Ohio, that:

38 The County Executive is hereby authorized to execute an agreement with Stark County
39 for the sale of a decontamination trailer and tow vehicle owned by the County of Summit, for the
40 amount of \$25,000.00.

44 This Resolution is hereby declared to be an emergency measure in the interest of the
45 health, safety and welfare of the citizens of the County of Summit, Ohio, and for the further
46 reason that it is necessary in order to immediately authorize the Executive to execute an
47 agreement with Stark County to sell it a needed decontamination trailer and tow vehicle.
