7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Local 1032 (Clerical and Technical Unit) and Ohio Council 8 of the**
9 **American Federation of State, County and Municipal Employees, AFL-CIO and the**
10 **County of Summit and the County Engineer, for the period 4/1/12 through 3/31/15, for the**
11 **Executive, and declaring an emergency.**

13 WHEREAS, a collective bargaining agreement has been reached between Local 1032
14 (Clerical and Technical Unit) and Ohio Council 8 of the American Federation of State, County
15 and Municipal Employees, AFL-CIO, the County of Summit and the County Engineer, for the
16 period 4/1/12 through 3/31/15; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that authorizing the County Executive to execute the aforementioned collective bargaining
20 agreement is necessary and in the best interest of the County of Summit;

27 The County Executive is hereby authorized to execute a collective bargaining agreement
28 between Local 1032 (Clerical and Technical Unit) and Ohio Council 8 of the American
29 Federation of State, County and Municipal Employees, AFL-CIO and the County of Summit and
30 the County Engineer, for the period 4/1/12 through 3/31/15.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit and for the for the further purpose of providing a
36 timely collective bargaining agreement between Local 1032 (Clerical and Technical Unit) and
37 Ohio Council 8 of the American Federation of State, County and Municipal Employees, AFL-
38 CIO, and the County of Summit and the County Engineer.
