7 **A Resolution appropriating additional funds for the Medical Examiner's Laboratory Fund**  
8 **in the amount of \$42,000.00 through 12/31/12, for the Medical Examiner, and declaring an**  
9 **emergency.**

11 WHEREAS, the Medical Examiner has surplus cash reserves in the Medical Examiner's  
12 Laboratory Fund; and

13  
14 WHEREAS, the funds are required for the purchase of a three-year contract for drug  
15 screen reagents with Siemens Healthcare Diagnostics, these reagents being the only ones that are  
16 compatible with the Medical Examiner's current equipment; and

17  
18 WHEREAS, the Medical Examiner's current equipment and these drug screening  
19 reagents are the most efficient method for screening of common drugs of abuse; and

20  
21 WHEREAS, the Medical Examiner will require a supplement from its cash reserves to be  
22 appropriated for this expense in calendar year 2012; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to appropriate the funds in  
26 the amount of \$42,000.00;
