12 order with D&G Uniforms for the yearly expense for uniform allowance, as Best Practical
13 Source, in an amount not to exceed \$40,000.00; and

16 that the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a purchase order with D&G Uniforms for the
24 yearly expense for uniform allowance, as Best Practical Source, in an amount not to exceed
25 \$40,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
26 purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide for the aforementioned uniform allowance.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
