13 WHEREAS, the Board of Control, at its meeting held April 11, 2012, awarded a
14 professional service contract with Community Support Services, Inc., for payeeship services for
15 Adult Protective Services clients, for the period 5/1/12 through 9/30/12, with one option to renew
16 for the period 10/1/12 through 9/30/13, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Community
27 Support Services, Inc., for payeeship services for Adult Protective Services clients, for the period
28 5/1/12 through 9/30/12, with one option to renew for the period 10/1/12 through 9/30/13, in an
29 amount not to exceed \$50,000.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide payeeship services beginning 5/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
