7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive to hire**
9 **externally one person into the full-time, classified, non-bargaining position of Land**
10 **Development Administrator, at an annual rate not to exceed \$55,161.60, for the Executive's**
11 **Department of Community and Economic Development, and declaring an emergency.**

13 WHEREAS, pursuant to Resolution No's. 2009-110 and 2011-204, this Council enacted
14 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled
15 "Temporary Hiring Freeze," as a budgetary control measure; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employee; and

22 WHEREAS, the Executive says it is necessary for the continued and effective operation
23 of his office to be permitted to hire externally one person into the full-time, classified, non-
24 bargaining position of Land Development Administrator, at an annual rate not to exceed
25 \$55,161.60; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
29 hire externally one person into the full-time, classified, non-bargaining position of Land
30 Development Administrator, at an annual rate not to exceed \$55,161.60;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
33 that:

37 County Council hereby determines that it is necessary for the continued and effective
38 operation of the Executive's Office, and further authorizes the Executive to hire externally one
39 person into the full-time, classified, non-bargaining position of Land Development
40 Administrator, at an annual rate not to exceed \$55,161.60.

44 This Resolution is hereby declared to be an emergency in the interest of the health, safety
45 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
46 to immediately authorize the Executive to hire the aforementioned position to ensure the ongoing
47 effective operation of that office.
