7 **A Resolution appropriating funds in the amount of \$14,034.06 in carryover balances for**
8 **the County of Summit Program Year 2011 Home Weatherization Assistance Program, with**
9 **no local cash match requirement, through 12/31/12, for the Executive's Department of**
10 **Community and Economic Development, and declaring an emergency.**

12 WHEREAS, the County of Summit is in receipt of carryover federal funds in its 2011
13 Home Weatherization Assistance Program ("HWAP") grant, with no local cash match
14 requirement, awarded by the State of Ohio, and appropriated in Resolution No. 2011-270, which
15 provides funding for necessary home improvements to low income citizens; and

16
17 WHEREAS, 147 jobs were completed in 2011 and \$14,034.06 still remains available in
18 purchase orders at the end of 2011 which must be reappropriated for use in 2012; and

19
20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to appropriate the
22 aforementioned funds in the amount of \$14,034.06;


