4 **A Resolution authorizing the County Executive to execute agreements and amendments to**  
5 **existing agreements with various local employers for participation and reimbursement**  
6 **through the Workforce Investment Act On the Job Training program, in an amount not to**  
7 **exceed \$500,000.00 collectively, for the period 7/1/12 through 6/30/13, for the Executive's**  
8 **Department of Job and Family Services, and declaring an emergency.**

10 WHEREAS, pursuant to Resolution No. 2011-243, this Council authorized the County  
11 Executive to execute agreements with various employers for participation and reimbursement  
12 through the Workforce Investment Act On the Job Training ("WIA OJT") program, in an amount  
13 not to exceed \$500,000.00 collectively, for the period 7/1/11 through 6/30/12; and

14  
15 WHEREAS, the Executive's Department of Job and Family Services anticipates that  
16 authority to expend said WIA OJT funds will be expire on 6/30/12, but desires to continue the  
17 program with an additional \$500,000.00 in WIA OJT funding, in order to continue reimbursing  
18 current and additional employers for newly hired employees, for the period 7/1/12 through  
19 6/30/13; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that it is necessary and in the best interest of the County to authorize the Executive to execute  
23 agreements and amendments to existing agreements with various local employers for  
24 participation and reimbursement through the WIA OJT program, in an amount not to exceed  
25 \$500,000.00 collectively, for the period 7/1/12 through 6/30/13;

27 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
28 State of Ohio, that:

32 The County Executive is hereby authorized to execute agreements and amendments to  
33 existing agreements with various local employers for participation and reimbursement through  
34 the Workforce Investment Act On the Job Training ("WIA OJT") program, in an amount not to  
35 exceed \$500,000.00 collectively, for the period 7/1/12 through 6/30/13.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately allow  
41 the Executive to enter into the any necessary agreements and amendments in order to timely  
42 expend the WIA OJT funds.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.


