13 WHEREAS, the Board of Control, at its meeting held May 9, 2012, awarded various
14 professional service contract renewals (second and final), per attached Exhibit A, for Workforce
15 Investment Act youth program services, for the period 7/1/12 through 6/30/13, subject to
16 confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewals are necessary and in the best interest of the County of Summit;

27 (second and final), per attached Exhibit A, for Workforce Investment Act youth program
28 services, for the period 7/1/12 through 6/30/13, in a total amount not to exceed \$925,000.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such contract
30 renewals.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide Workforce Investment Act youth program services for the period beginning 7/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
