7 **A Resolution authorizing the County Executive to advertise for bids for security upgrades**  
8 **at the Ohio Building, in the City of Akron, in Council District 4, for an estimated total cost**

10 **declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for security upgrades at  
16 the Ohio Building, in the City of Akron, in Council District 4, for an estimated total cost not to  
17 exceed \$52,500.00; and

19 WHEREAS, a copy of the specifications are on file in the office of Clerk of Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that authorizing the County Executive to advertise for bids for security upgrades at the Ohio  
23 Building, is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for security upgrades at the Ohio  
31 Building, in the City of Akron, in Council District 4, for an estimated total cost not to exceed  
32 \$52,500.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
37 of the citizens of the County of Summit, and for the further reason that it authorizes the  
38 Executive to immediately advertise for bids needed for security upgrades at the Ohio Building.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.
