A Resolution authorizing the County Executive to execute a Human Resource Training Agreement with political subdivisions that wish to participate in the County's Human Resource Training Program, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, all political subdivisions must engage in certain training of their employees; and

WHEREAS, the County desires to collaborate with those political subdivisions by offering the County's employee training to the employees of those political subdivisions; and

WHEREAS, to facilitate such training, the Executive's Office has developed a Human Resource Training Agreement; and

WHEREAS, the County has further determined that a political subdivision's participation under the Human Resource Training Agreement shall be operated on a cost-neutral basis to the County and that accordingly, the participating political subdivision shall pay certain fees as set forth in the Human Resource Training Agreement; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned Agreement with political subdivisions that wish to participate in the Human Resource Training Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

DECOLUTIONING 2012 260

The County Executive is hereby authorized to execute a Human Resource Training Agreement, attached hereto as Exhibit A and incorporated herein as if fully restated, with political subdivisions that wish to participate in the County's Human Resource Training Program. The Human Resource Training Agreement is approved with changes therein not inconsistent with this Resolution and not substantially adverse to the County which shall be approved by the County Executive; provided that the approval of those changes by the County Executive and the character of such changes as not being substantially adverse to the County shall be evidenced conclusively by the execution of the Human Resource Training Agreement.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately authorizing the Executive to execute a Human Resource Training Agreement with County political subdivisions that wish to participate in the County's Human Resource Training Agreement, in order to fulfill the training needs of those political subdivisions.
