7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Village Network for trauma-focused, cognitive**
9 **behavioral therapy services for program-involved families, in an amount not to exceed**
10 **\$30,000.00 (25% increase), for the Court of Common Pleas – Juvenile Division, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 13, 2012, awarded Change
14 Order No. 1 to a professional service contract with Village Network for trauma-focused,
15 cognitive behavioral therapy services for program-involved families, in an amount not to exceed
16 \$30,000.00 (25% increase), subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
19 that the change order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of Change Order No. 1 to a professional service
27 contract with Village Network for trauma-focused, cognitive behavioral therapy services for
28 program-involved families, in an amount not to exceed \$30,000.00 (25% increase), is hereby
29 confirmed and the County Executive is hereby authorized to execute such change order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned behavioral therapy services.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.


