14 WHEREAS, the Board of Control, at its meeting held June 13, 2012, awarded a
15 professional service contract with County Commissioners Association of Ohio Service
16 Corporation and Ohio Child Support Enforcement Agency Director's Association for a renewal
17 agreement (first of five) for employment verifications services, for the period 7/1/12 through
18 6/30/13, subject to confirmation by County Council; and,

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with County
29 Commissioners Association of Ohio Service Corporation and Ohio Child Support Enforcement
30 Agency Director's Association for a renewal agreement (first of five) for employment
31 verification services, for the period 7/1/12 through 6/30/13, in an amount not to exceed
32 \$58,023.46, is hereby confirmed and the County Executive is hereby authorized to execute such
33 contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 provide for the contract effective 7/1/12.

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.


