7 **A Resolution adjusting existing appropriations by \$11,929.00 within the Federal Fiscal**
8 **Year 2012 Victims of Crime Act and the State Victims Assistance Act Grant Program, for**
9 **the period 10/1/11 through 9/30/12, for the Prosecutor, and declaring an emergency.**

11 WHEREAS, this Council, pursuant to Resolution No. 2012-429, accepted and
12 appropriated grant funds for the Federal Fiscal Year 2012 Victims of Crime Act ("VOCA") and
13 the State Victims Assistance Act ("SVAA") Grant, awarded by the State of Ohio Attorney
14 General's Office to the County of Summit Prosecutor's Office; and

16 WHEREAS, the State of Ohio Attorney General's Office has required that the SVAA
17 portion of the funding be reported separately from the VOCA funds; and

19 WHEREAS, \$11,929.00 in the original appropriations for SVAA funding will be moved
20 to a new Banner organization number in order to meet the Attorney General's reporting
21 requirements; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the adjustment to the appropriations of the aforementioned grant fund is necessary and in the
25 best interest of the County of Summit;
