8 **contract with The University of Akron Training Center for Fire and Hazardous Materials**

11 **Insurance and Risk Management-Emergency Management Agency, and declaring an**

14 WHEREAS, the Board of Control, at its meeting held July 25, 2012, awarded a
15 professional service contract with The University of Akron Training Center for Fire and
16 Hazardous Materials for professional services to support the Summit County Special Operations
17 Response Team, subject to confirmation by County Council; and,

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The award by the Board of Control of a professional service contract with The University
28 of Akron Training Center for Fire and Hazardous Materials for professional services to support
29 the Summit County Special Operations Response Team, in an amount not to exceed \$26,200.00,
30 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the professional services.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
