7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Federal Fiscal Year 2013 Temporary Assistance to Needy Families**
9 **grant from the Executive's Department of Job and Family Services to the County of**
10 **Summit Juvenile Court for its Family Resource Center program, in the amount of**
11 **\$340,000.00, with no local cash match requirement, for the period 10/1/12 through 9/30/13,**
12 **and appropriating these funds through 12/31/12, for the Court of Common Pleas – Juvenile**
13 **Division, and declaring an emergency.**

15 WHEREAS, the Court of Common Pleas – Juvenile Division has received an award of a
16 Federal Fiscal Year 2013 (“FFY 2013”) Temporary Assistance to Needy Families (“TANF”)
17 grant from the Executive’s Department of Job and Family Services, for the Juvenile Court’s
18 Family Resource Center (“FRC”) program, in the amount of \$340,000.00, with no local cash
19 match requirement, for the period 10/1/12 through 9/30/13; and

21 WHEREAS, the FRC program provides families with intensive case management to at-
22 risk youth who are involved in any of the following situations: domestic violence, pregnancy,
23 parenting teens, teens at risk of dropping out of school and/or returning from long stays at the
24 detention center or other placement center; and

26 WHEREAS, the FRC program also provides resources for other court-involved youth,
27 and the County as a whole, being the central point of referral for all services available throughout
28 the County for youth and their families; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
32 execute any documents necessary to accept the award of the aforementioned FFY 2013 TANF
33 grant from the Executive’s Department of Job and Family Services to the Juvenile Court, and to
34 appropriate these grant funds;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The County Executive is hereby authorized to execute any documents necessary to accept
42 an award of a Federal Fiscal Year 2013 (“FFY 2013”) Temporary Assistance to Needy Families

44 Summit Juvenile Court for the for its Family Resource Center (“FRC”) program, in the amount
45 of \$340,000.00, with no local cash match requirement, for the period 10/1/12 through 9/30/13.
