7 **A Resolution setting the rate of petit juror compensation for petit jurors serving the**
8 **County of Summit, for the Court of Common Pleas, General Division, and declaring an**
9 **emergency.**

10
11 WHEREAS, pursuant to Section 2313.34 of the Ohio Revised Code, this Council has the
12 authority to fix the compensation of each petit juror that serves the County, payable out of the
13 General Fund; and

14
15 WHEREAS, pursuant to Resolution No. 2000-076, this Council established the rate of
16 compensation for petit jurors at \$20.00 per day for the first ten days of service and \$30.00 per
17 day for each day of service after the first ten days; and

18
19 WHEREAS, pursuant to Resolution 2009-462 this Council set the compensation for petit
20 jurors as parking validations for the first ten days and \$15.00 per day for every day over the first
21 ten days until December 31, 2012, to return to the rate set by Resolution No. 2000-76 on January
22 1, 2013; and

24 WHEREAS, budgetary constraints justify leaving the compensation established by
25 Resolution 2009-462 in place following December 31, 2012; and

27 WHEREAS, the Judges of the Court of Common Pleas, General Division, have recently
28 adopted an order requesting that the compensation established by Resolution 2009-462 remain in
29 place after December 31, 2012.

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
32 State of Ohio, that:

34 SECTION 1

36 Effective January 1, 2013, and pursuant to Section 2313.34 of the Ohio Revised Code,
37 the rate of compensation for petit jurors serving the County shall be as follows:

39 (1) For the first ten days of service, petit jurors shall receive compensation in the form of
40 parking validation on days in which they serve as jurors for any of the following
41 decks: Summit County Parking Deck, located at 200 South High Street, Akron, Ohio;
42 Morley Parking Deck, located at 177 South Broadway, Akron, Ohio; Broadway
43 Parking Deck, located at 120 South Broadway, Akron, Ohio; and High Market
44 Parking Deck, located at 40 South High Street, Akron Ohio. No other compensation
45 shall be paid during these days of service.

47 (2) For each day of service after the first ten days of service, petit jurors shall receive
48 compensation in the amount of \$15.00 per day.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for the further reason to immediately set the
8 petit juror compensation prior to the end of this calendar year.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
14 and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including Section
22 121.22 of the Ohio Revised Code.
