13 WHEREAS, the County of Summit wishes to execute a professional service contract,
14 subject to the approval of the Board of Control, with Summit County Public Health, for an
15 intergovernmental agreement to provide maternal depression services, for Federal Fiscal Year
16 2012, for the period 9/1/12 through 9/30/12; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit, and that the
20 Executive should be authorized to execute the same, subject to the approval of the Board of
21 Control;

28 The County Executive is hereby authorized to execute a professional service contract,
29 subject to the approval of the Board of Control, with Summit County Public Health, for an
30 intergovernmental agreement to provide maternal depression services, for Federal Fiscal Year
31 2012, for the period 9/1/12 through 9/30/12, in an amount not to exceed \$40,260.00.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further purpose to immediately
37 authorize the Executive to execute the aforementioned intergovernmental agreement, subject to
38 the approval of the Board of Control, to provide maternal depression services for Federal Fiscal
39 Year 2012, for the period 9/1/12 through 9/30/12.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.


