24 case files, under State Term Pricing, in an amount not to exceed \$34,172.95, is hereby confirmed
25 and the County Executive is hereby authorized to execute such purchase order.

29 This Resolution is hereby declared an emergency in the interest of the health, safety and
30 welfare of the citizens of the County of Summit, and for the further reason to immediately
31 provide the aforementioned case files.

36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
37 effect and be in force at the earliest time provided by law.
