7 **A Resolution adjusting existing appropriations in the amount of \$70,000.00 within the**
8 **Prosecutor's General Fund in the 2012 operating budget, for the fiscal year ending**
9 **12/31/12, for the County of Summit Prosecutor, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2011-483, which approved
12 and appropriated the 2012 operating budget for the County of Summit, which included salary
13 appropriations in the Prosecutor's General Fund for the fiscal year ending 12/31/12; and

15 WHEREAS, due to vacancies and salary reimbursements from IV-E funds, a surplus
16 exists within the Prosecutor's Office's salary appropriations; and

18 WHEREAS, it is necessary to adjust \$70,000.00 in current salary appropriations in order
19 to provide funding for Local Grant Matches, as well as Other Expenses, including computer
20 repairs and licensing as well as other equipment and vehicle issues; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned adjustment of the existing appropriation is necessary and in the best
24 interest of the County of Summit;
