7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Temporary Assistance to Needy Families award of federal funds from the County**
9 **of Summit Department of Job and Family Services for the Family Resource Center**
10 **Program, in the amount of \$340,000.00, with no local cash match requirement, with a**
11 **performance period of 10/1/12 through 9/30/13, and appropriating these funds through**
12 **12/31/12, for the Court of Common Pleas - Juvenile Division, and declaring an emergency.**

14 WHEREAS, the County of Summit Juvenile Court has received a Temporary Assistance
15 to Needy Families (“TANF”) award of federal funds in the amount of \$340,000.00, with no local
16 cash match requirement, from County Department of Job and Family Services (“DJFS”), for the
17 Family Resource Center (“FRC”) Program for the period 10/1/12 through 9/30/13; and

19 WHEREAS, the FRC Program provides families with intensive case management to at-
20 risk youth who are involved in any of the following situations; domestic violence, pregnancy, are
21 parenting teens, teens at risk of dropping out of school, and/or returning from long stays at the
22 detention center or other placement center; and

24 WHEREAS, the FRC Program also provides resources for other court involved youth,
25 and the County as a whole, being the central point of referral for all services available throughout
26 the County for youth and their families; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 execute any documents necessary to accept the award of the aforementioned grant from the
31 DJFS, and to appropriate these grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The County Executive is hereby authorized to execute any documents necessary to accept
39 a Temporary Assistance to Needy Families (“TANF”) award of federal funds from the County of
40 Summit Department of Job and Family Services (“SCDJFS”), for the Family Resource Center
41 (“FRC”), in the amount of \$340,000.00, with no local cash match requirement, for the period
42 10/1/12 through 9/30/13.
