7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of federal funds from the State of Ohio Attorney General's Office of a**
9 **Federal Fiscal Year 2013 Victims of Crime Act grant of \$62,941.00, with a local cash match**
10 **of \$25,280.00, and State Victims Assistance Act grant in the amount of \$3,470.00, with no**
11 **local cash match requirement, for the period 10/1/12 through 9/30/13, and appropriating**
12 **\$91,691.00 for expenditures through 12/31/12, for the Prosecutor, and declaring an**
13 **emergency.**

14
15 WHEREAS, the County Prosecutor's Office has received an award from the State of
16 Ohio Attorney General's Office of a Federal Fiscal Year 2013 Victims of Crime Act ("VOCA")
17 grant in the amount of \$62,941.00, which has a 25% local cash match requirement of
18 \$20,980.00, for a VOCA award total of \$87,391.00, for the period 10/1/12 through 9/30/13; and

20 WHEREAS, the Prosecutor's Office has received an award from the State of Ohio
21 Attorney General's Office of a Federal Fiscal Year 2013 State Victims Assistance Act
22 ("SVAA") grant in the amount of \$3,470.00, with no local cash match requirement, for the
23 period 10/1/12 through 9/30/13, and which the Ohio Attorney General's Office requires an
24 accounting identity separate from the VOCA award; and

26 WHEREAS, the VOCA and SVAA are annual grants which help to support salary and
27 benefits for a Victim Advocate and a Victim Services Coordinator, both full-time staff providing
28 advocacy services to crime victims in Summit County; and

30 WHEREAS, State reductions in these annual grants awards have to be supplemented with
31 \$4,300.00 from the Prosecutor's general funds to fully support the salary and benefits for these
32 victim advocate staff; and

34 WHEREAS, the Prosecutor's Office provides for the required VOCA grant match within
35 their annual budget; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
39 execute any documents necessary to accept the award of the aforementioned grants from the
40 State of Ohio Attorney General's Office, and to appropriate these grant funds;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The County Executive is hereby authorized to execute any documents necessary to accept
48 the awards of a Federal Fiscal Year 2013 Victims of Crime Act ("VOCA") grant in the amount
49 of \$62,941.00, with a local cash match requirement of \$20,980.00, and a State Victims
50 Assistance Act ("SVAA") grant in the amount of \$3,470.00 from the State of Ohio Attorney
51 General's Office, for the period 10/1/12 through 9/30/13.


