7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of a High Visibility Enforcement Overtime grant, from the Ohio**  
9 **Department of Public Safety, in the amount of \$78,201.34, with no local cash match**  
10 **requirement, for the period 10/1/12 through 9/30/13, and appropriating the grant funds, for**  
11 **the period 10/1/12 through 12/31/12, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County of Summit Sheriff's Office has been awarded \$78,201.34, with no  
14 local cash match requirement, from Ohio Department of Public Safety ("ODPS"), through their  
15 Office of Criminal Justice Services ("OCJS"), in order to operate the High Visibility  
16 Enforcement Overtime ("HVEO") program in the County of Summit, for the period 10/1/12  
17 through 9/30/13; and

19 WHEREAS, the HVEO grant has provided funding for the past 13 years to the Sheriff's  
20 Office for overtime in order to conduct high visibility enforcement, public awareness, and  
21 education in the County of Summit; and

23 WHEREAS, it is necessary to appropriate grant funds for the period 10/1/12 through  
24 12/31/12; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that authorizing the County Executive to execute any documents necessary to accept the  
28 aforementioned grant, and the appropriations of the aforementioned grant funds, is necessary and  
29 in the best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept  
37 a grant award from the Ohio Department of Public Safety for a High Visibility Enforcement  
38 Overtime ("HVEO") grant, in the amount of \$78,201.34, with no local cash match requirement,  
39 for the period 10/1/12 through 9/30/13.
