7 **A Resolution authorizing the County Executive to advertise for bids for the purchase of 14**
8 **LiveScan fingerprint machines for law enforcement agencies in Ohio Homeland Security**
9 **Region 5, for an estimated total cost not to exceed \$380,000.00, for the Executive's**
10 **Department of Law, Insurance and Risk Management – Division of Public Safety, and**
11 **declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

15
16 WHEREAS, the Homeland Security Region 5 Advisory Committee has recommended
17 the purchase of 14 LiveScan fingerprint machines for law enforcement agencies throughout the
18 Region to be funded from the regional Law Enforcement – State Homeland Security Program
19 ("LE-SHSP") grant, in an amount not to exceed \$380,000.00; and

21 WHEREAS, the County Executive, as the fiscal agent for the LE-SHSP grant wishes to
22 advertise for bids for the aforementioned equipment purchase; and

24 WHEREAS, a copy of the bid specifications is on file in the office of the Clerk of
25 Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to advertise for bids for the
29 aforementioned equipment;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is authorized to advertise for bids for 14 LiveScan fingerprint
37 machines, for an estimated total cost not to exceed \$380,000.00.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit and for the further reason that it authorizes the
43 Executive to immediately advertise for bids for LiveScan fingerprint machines and expend grant
44 funds within the grant performance period.
