7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Proware, Inc., for maintenance and support for the Court of Common Pleas**  
9 **case management system, as Best Practical Source, approved by the IT Board 10/16/12, in**  
10 **an amount not to exceed \$147,587.00, for the Court of Common Pleas, and declaring an**  
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 17, 2012, awarded a  
14 contract with Proware, Inc., for maintenance and support for the Court of Common Pleas case  
15 management system, as Best Practical Source, approved by the IT Board 10/16/12, subject to  
16 confirmation by County Council; and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that  
19 the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with Proware, Inc.,  
27 for maintenance and support for the Court of Common Pleas case management system, as Best  
28 Practical Source, approved by the IT Board 10/16/12, in an amount not to exceed \$147,587.00, is  
29 hereby confirmed and the County Executive is hereby authorized to execute such contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to provide case  
35 management system maintenance and support.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.
