7 **A Resolution establishing the compensation of the County of Summit Human Resource**  
8 **Commission members at an annual salary of \$7,800.00, with no fringe benefits, to be paid**  
9 **in 26 equal payments, for the Executive, and declaring an emergency.**

11 WHEREAS, pursuant to the County of Summit Charter, Section 6.01, the County of  
12 Summit Council is authorized to review and establish the compensation for the Members of the  
13 Human Resource Commission ("HRC"); and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
16 that the compensation for HRC members should be at an annual salary of \$7,800.00, with no  
17 fringe benefits, to be paid in 26 equal payments;

19 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
20 State of Ohio, that:

22 SECTION 1

24 Each member of the County of Summit Human Resource Commission ("HRC") shall be  
25 compensated at an annual salary of \$7,800.00, with no fringe benefits, other than Public  
26 Employee Retirement System of Ohio, to be paid in 26 equal payments.

28 SECTION 2

30 This Resolution is hereby declared to be an emergency in the interest of the health,  
31 safety, and welfare of the citizens of the County of Summit, and for the further reason to  
32 establish a fair compensation for the HRC members for 2013 and beyond.

34 SECTION 3

36 Provided this Resolution receives the affirmative vote of eight members, it shall take  
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
38 effect and be in force at the earliest time provided by law.

42 It is found and determined that all formal actions of this Council concerning and relating  
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
44 deliberations of this Council and of any of its committees that resulted in such formal action,  
45 were in meetings open to the public, in compliance with all legal requirements, including Section  
46 121.22 of the Ohio Revised Code.
