7 **A Resolution appropriating funds for the Juvenile Court Clerk Fees fund in the amount of**

11 WHEREAS, the Internal Revenue Service ("IRS") issued Regulation 6045, on the  
12 requirement to issue an IRS Form 1099, to report annual gross payments to an attorney for the  
13 payment of legal services aggregating \$600.00 or more in a calendar year; and

14  
15 WHEREAS, in review of this IRS regulation, it is the consensus of the County of Summit  
16 Internal Audit, Fiscal and Juvenile Court offices that the Juvenile Court should establish a new  
17 fund to record fee payments; and

19 WHEREAS, the Juvenile Court Clerk Fees fund will allow the Juvenile Court to pay  
20 attorney services costs and provide the necessary documentation for compliance with IRS  
21 Regulation 6045; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to appropriate the  
25 aforementioned funds in the amount of \$10,000.00;
