7 **A Resolution authorizing the County Executive to execute a first renewal to an agreement with**
8 **the Portage County Combined General Health District for back-up plumbing inspection**
9 **services, to be provided upon request by either county, at a rate of \$71.53 per hour, plus**
10 **mileage reimbursement at \$.55 per mile and business expenses, for the period of 1/1/13 to**
11 **12/31/13, for the Executive's Department of Community and Economic Development, Division**
12 **of Building Standards, and declaring an emergency.**

14 WHEREAS, both Summit County and the Portage County Combined General Health District
15 are charged with the enforcement of plumbing rules and regulations and have employed certified
16 plumbing inspectors; and

17
18 WHEREAS, both entities need part-time occasional certified plumbing inspectors to
19 supplement full-time certified employees by reason of their employees being on leave; and

20
21 WHEREAS, it is most cost effective for each entity to use neighboring agencies' personnel
22 for back-up plumbing inspection services; and

23
24 WHEREAS, pursuant to Resolution No. 2011-539, this Council authorized the Executive to
25 execute an agreement with the Portage County Combined General Health District to provide each
26 other with back-up plumbing inspection services for the period of 1/1/12 to 12/31/12; and

28 WHEREAS, Summit County and the Portage County Combined General Health District
29 desire to execute a first renewal to the agreement, pursuant to which each entity will provide the
30 other with back-up plumbing inspection services at a rate of \$71.53 per hour, plus mileage
31 reimbursement at \$.55 per mile and business expenses, for the period of 1/1/13 to 12/31/13; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that
34 it is necessary and in the best interest of the County of Summit to authorize the Executive to execute
35 a first renewal to the agreement with the Portage County Combined General Health District for back-
36 up plumbing inspection services.

38 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of
39 Ohio, that:

43 The Executive is hereby authorized to execute a first renewal to the agreement with the
44 Portage County Combined General Health District, pursuant to which each entity will provide the
45 other with back-up plumbing inspection services at a rate of \$71.53 per hour, plus mileage
46 reimbursement at \$.55 per mile and business expenses, for the period of 1/1/13 to 12/31/13.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and
51 welfare of the citizens of the County of Summit and for the further reason to immediately authorize
52 the Executive to execute said renewal so that the same is in effect prior to the commencement date of
53 the renewal.
