8 **An Ordinance amending Chapter 923 of the Codified Ordinances, entitled “Fees and User**  
9 **Charge System”, to extend the current 2012 sewer charges, surcharges and fees into 2013,**  
10 **for the Executive’s Department of Environmental Services, and declaring an emergency.**

11 WHEREAS, in Ordinance No. 2006-550, the County Council amended certain sections  
12 of Chapter 923 of the Codified Ordinances of the County of Summit, entitled “Fees and User  
13 Charge System”, and set the various user charges, surcharges and fees for the Summit County  
14 Metropolitan Sewer District, administered by the Executive’s Department of Environmental  
15 Services.

16  
17 WHEREAS, the current Chapter 923 contains user charges, surcharges and fees for  
18 calendar years 2007 through 2012;

19  
20 WHEREAS, it is necessary to set all user charges, surcharges and fees in Chapter 923 for  
21 the year 2013; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that the  
24 user charges, surcharges and fees contained in Chapter 923 of the Codified Ordinances of the  
25 County of Summit should remain at the same rates and amounts in the year 2013 as they are for  
26 the current year 2012; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
29 necessary to amend Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the  
30 Codified Ordinances of the County of Summit to implement said extension of the user charges,  
31 surcharges and fees; and

33 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
34 of Ohio, that:

38 Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
39 Ordinances of the County of Summit are hereby amended as shown on Exhibit A, attached  
40 hereto and incorporated herein as if fully restated.

44 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
45 welfare of the citizens of the County of Summit, and for the further reason of immediately  
46 amending Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
47 Ordinances of the County of Summit, in order to immediately implement the user charges,  
48 surcharges and fees for the Summit County Metropolitan Sewer District for the year 2013.
