7 **A Resolution of support for the Northeast Ohio Four County Regional Planning and**
8 **Development Organization's 2013 grant application to the Economic Development**
9 **Administration and for the 2013-2016 Northeast Ohio Four County Regional Planning and**
10 **Development Organization Economic Development Planning Program, for the Executive,**
11 **and declaring an emergency.**

13 WHEREAS, the Public Works and Economic Development Act of 1965, 42 U.S.C.
14 Sections 3132-3233, as amended, delegates to the Economic Development Administration
15 ("EDA") responsibility of assisting in the development of multi-county planning districts
16 through project grants which assure effective utilization of local resources in creating full-time
17 permanent jobs for the unemployed and the underemployed; and

18
19 WHEREAS, the purpose of the 1998 amendment to the Act was to further authorize
20 economic assistance in the form of planning, and implementation grants under Title I and II to
21 areas experiencing unemployment caused by structural changes in the area's economy; and

23 WHEREAS, the EDA is authorized through planning and implementation grants to assist
24 area planning efforts to solve problems of economic growth, unemployment and
25 underemployment; and

27 WHEREAS, the Northeast Ohio Four County Regional Planning and Development
28 Organization ("NEFCO") General Policy Board, in conjunction with its 128 local units of
29 government, has formulated the 2013-2016 NEFCO Economic Development Planning Program;
30 and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to declare the County's
34 support for NEFCO's 2013 grant application to EDA and for the 2013-2016 NEFCO Economic
35 Development Planning Program;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The County of Summit hereby states its support for the Northeast Ohio Four County
43 Regional Planning and Development Organization ("NEFCO") grant application to the
