7 **A Resolution confirming an award by the Board of Control of a purchase order with MNJ**
8 **Technologies Public Sector, LLC, as a GSA vendor, for hardware equipment for**
9 **virtualization of servers, approved by the IT Board 11/20/12, in an amount not to exceed**
10 **\$55,601.70, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 21, 2012, awarded a
14 purchase order with MNJ Technologies Public Sector, LLC, as a GSA vendor, for hardware
15 equipment for virtualization of servers, approved by the IT Board 11/20/12, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase order with MNJ Technologies Public
27 Sector, LLC, as a GSA vendor, for hardware equipment for virtualization of servers, approved by
28 the IT Board 11/20/12, in an amount not to exceed \$55,601.70, is hereby confirmed and the
29 County Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide upgrades for the servers.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,




