12 WHEREAS, the County Executive's Department of Job and Family Services has an  
13 aging fleet of vehicles; and

15 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
16 requires this Council's authorization for the County Executive to advertise for bids; and

18 WHEREAS, the Executive wishes to advertise for bids for three 7-passenger vans for use  
19 by the Department of Job and Family Services, for an estimated cost not to exceed \$75,000.00;

22 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of  
23 Council; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 advertise for bids for the aforementioned vehicles;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The County Executive is authorized to advertise for bids for three 7-passenger vans for  
35 use by the Department of Job and Family Services, for an estimated cost not to exceed  
36 \$75,000.00.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
41 of the citizens of the County of Summit, and for the further reason that it authorizes the  
42 Executive to immediately advertise for bids for necessary vehicles for the Department of Job and  
43 Family Services.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
