8 **mailing and CASS address file certification, for real estate tax bills and dog licenses for the**

10 **to renew for an additional two-year term, for an estimated cost not to exceed \$500,000.00,**  
11 **for the Fiscal Officer, and declaring an emergency.**

13 WHEREAS, the County Fiscal Officer desires to have the County Executive advertise for  
14 bids for printing, mailing and CASS address file certification services for the Fiscal Office, for a  
15 two-year term, from 1/01/13 through 12/31/14, with two options to renew for an additional two-  
16 year term, for an estimated cost not to exceed \$500,000.00; and

18 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of  
19 Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for the aforementioned purpose;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that;

30 The County Executive is authorized to advertise for bids for the printing, mailing and  
31 CASS address file certification, for real estate tax bills and dog licenses for the County Fiscal  
32 Office, for a two-year term, from 1/01/13 through 12/31/14, with two options to renew for an  
33 additional two-year term, for an estimated cost not to exceed \$500,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
38 of the citizens of the County of Summit, and for the further reason that it authorizes the  
39 Executive to immediately advertise for bids for necessary services for the Fiscal Office from  
40 2013-2014.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
