7 **A Resolution, pursuant to Section 169.04(i) of the Codified Ordinances of the County of**  
8 **Summit, extending the deadline for this Council to approve the 2013 Report on Staffing**  
9 **until January 28, 2013, for the Executive and Council, and declaring an emergency.**

11 WHEREAS, Section 169.04(i) of the Codified Ordinances of the County of Summit  
12 provides for a Report on Staffing to be submitted annually by the County Executive to this  
13 Council for the following calendar year, and for this Council to approve the same prior to  
14 December 31<sup>st</sup> of each year; and

16 WHEREAS, Section 169.04(i) further permits this Council, upon a two-thirds vote of its  
17 members, to extend the deadline for adoption beyond December 31<sup>st</sup>; and

19 WHEREAS, this Council desires additional time to consider the Report on Staffing for  
20 calendar year 2013; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County to extend the deadline for adoption of  
24 the 2013 Report on Staffing to January 28, 2013;

26 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
27 State of Ohio, that:

29 SECTION 1

31 Provided this Resolution is adopted with the approval of two-thirds of the members of  
32 this Council, the deadline for the Report on Staffing for calendar year 2013 is hereby extended  
33 until January 28, 2013. The 2012 Report on Staffing shall remain in effect until the 2013 Report  
34 on Staffing is adopted by Council.

38 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
39 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
40 to immediately extend the deadline for the adoption of the 2013 Report on Staffing prior to the  
41 expiration of that deadline.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
47 and be in force at the earliest time provided by law.

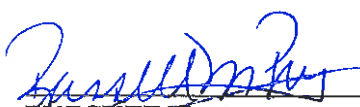
