7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Proware to update the County of Summit Court of Common Pleas – Juvenile**  
9 **Division’s case management system, approved by the IT Board 2/26/13, as Best Practical**  
10 **Source, in an amount not to exceed \$28,760.00, for the Court of Common Pleas – Juvenile**  
11 **Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 6, 2013, awarded a  
14 professional service contract with Proware to update the County of Summit Court of Common  
15 Pleas – Juvenile Division’s case management system, approved by the IT Board 2/26/13, as Best  
16 Practical Source, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with Proware to  
27 update the County of Summit Court of Common Pleas – Juvenile Division’s case management  
28 system, approved by the IT Board 2/26/13, as Best Practical Source, in an amount not to exceed  
29 \$28,760.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
30 contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for case management system updates in 2013.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
