7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Tallmadge Asphalt & Paving Company for the 2013 Summit County 448 Resurfacing**
9 **Program - South, in an amount not to exceed \$734,248.78, for the Engineer, and declaring**
10 **an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 10, 2013, awarded a purchase
13 contract with Tallmadge Asphalt & Paving Company for the 2013 Summit County 448
14 Resurfacing Program - South, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase contract with Tallmadge Asphalt &
25 Paving Company for the 2013 Summit County 448 Resurfacing Program – South, in an amount
26 not to exceed \$734,248.78, is hereby confirmed and the County Executive is hereby authorized
27 to execute such purchase contract.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide for the resurfacing program in 2013.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
