7 **A Resolution confirming an award by the Board of Control of purchase contract with**
8 **Kenworth of Richfield for four new 2013 Kenworth cab and chassis components for single-**
9 **axle dump trucks, in an amount not to exceed \$377,240.00, for the Engineer, and declaring**
10 **an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 24, 2013, awarded a purchase
13 contract with Kenworth of Richfield for four new 2013 Kenworth cab and chassis components
14 for single-axle dump trucks, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

22 SECTION 1

24 The award by the Board of Control of a purchase contract with Kenworth of Richfield for
25 four new 2013 Kenworth cab and chassis components for single-axle dump trucks, in an amount
26 not to exceed \$377,240.00, is hereby confirmed and the County Executive is hereby authorized
27 to execute such purchase contract.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the cab and chassis components in 2013.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
