7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for grants received by the County of Summit**
9 **Child Support Enforcement Agency, during State Fiscal Year 2014 and 2015 (7/1/13**
10 **through 6/30/15), for the Prosecutor, and declaring an emergency.**

12 WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing 7/1/08,
13 the Ohio Department of Job and Family Services may only make grants to counties through
14 subgrant agreements as described in that Section; and

15
16 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
17 Department of Job and Family Services developed a standard subgrant agreement to be executed
18 by the commissioners of each county prior to receiving Department of Job and Family Services
19 grant funds; and

21 WHEREAS, the County of Summit Child Support Enforcement Agency has received
22 from the Ohio Department of Job and Family Services the standard subgrant agreement for State
23 Fiscal Year ("SFY") 2014 and 2015 that sets forth the rights and responsibilities of both the Ohio
24 Department of Job and Family Services and the County of Summit Child Support Enforcement
25 Agency in relation to any grant that is awarded for SFY 2014 and 2015; and

27 WHEREAS, the County of Summit Child Support Enforcement Agency anticipates
28 receiving grant funds from the Ohio Department of Job and Family Services for SFY 2014 and
29 2015; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the County
33 Executive to execute the subgrant agreement for SFY 2014 and 2015;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 The County Executive is hereby authorized to execute a subgrant agreement with the
41 Ohio Department of Job and Family Services for grants received by the County of Summit Child
42 Support Enforcement Agency for State Fiscal Year ("SFY") 2014 and 2015 (7/1/13 through
43 6/30/15). A copy of said subgrant agreement is attached hereto as Exhibit A and incorporated
44 herein by reference.

48 This Resolution is hereby declared an emergency in the interest of the health, safety, and
49 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to
50 immediately execute said subgrant agreement so that the County of Summit Child Support
51 Enforcement Agency is eligible to awarded grant funds from the Ohio Department of Job and
52 Family Services for SFY 2014 and 2015.
