7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with The Young Men's Christian Association of Akron, Inc., dba Akron Area**
9 **YMCA, for drop-in child care services at The Job Center, for all regardless of income, for**
10 **the period 7/1/13 through 6/30/14, with five one-year renewal options, in an amount not to**
11 **exceed \$67,346.58, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held April 24, 2013, awarded a
15 professional service contract with The Young Men's Christian Association of Akron, Inc., dba
16 Akron Area YMCA, for drop-in child care services at The Job Center, for all regardless of
17 income, for the period 7/1/13 through 6/30/14, with five one-year renewal options, subject to
18 confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the contract is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with The Young
29 Men's Christian Association of Akron, Inc., dba Akron Area YMCA, for drop-in child care
30 services at The Job Center, for all regardless of income, for the period 7/1/13 through 6/30/14,
31 with five one-year renewal options, in an amount not to exceed \$67,346.58, is hereby confirmed
32 and the County Executive is hereby authorized to execute such contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for drop-in child care services effective 7/1/13.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,

52 121.22 of the Ohio Revised Code.
