7 **A Resolution confirming an award by the Board of Control of a purchase order with Tyler**  
8 **Technologies for maintenance renewal covering updates and support of the integrated**  
9 **assessment system software, for the period 1/1/13 through 12/31/13, as Best Practical**  
10 **Source, approved by the IT Board 4/23/13, in an amount not to exceed \$166,950.00, for the**  
11 **Fiscal Officer, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 24, 2013, awarded a purchase  
14 order with Tyler Technologies for maintenance renewal covering updates and support of the  
15 integrated assessment system software, for the period 1/1/13 through 12/31/13, as Best Practical  
16 Source, approved by the IT Board 4/23/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a purchase order with Tyler Technologies for  
27 maintenance renewal covering updates and support of the integrated assessment system software,  
28 for the period 1/1/13 through 12/31/13, as Best Practical Source, approved by the IT Board  
29 4/23/13, in an amount not to exceed \$166,950.00, is hereby confirmed and the County Executive  
30 is hereby authorized to execute such purchase order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide software maintenance renewal in 2013.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
