7 **A Resolution repealing Chapter 148A of the Codified Ordinances of the County of Summit,**
8 **entitled "Housing Advisory Board," for the Executive's Department of Community and**
9 **Economic Development, and declaring an emergency.**

11 WHEREAS, in the early 2000s, the County was the recipient of certain housing trust
12 funds designated to be used on improving housing in Summit County; and

13
14 WHEREAS, this Council enacted Chapter 148A of the Codified Ordinances of the
15 County of Summit, entitled "Housing Advisory Board," to create a Housing Advisory Board to
16 advise the County in spending said housing trust funds; and

17
18 WHEREAS, the County has fully expended said housing trust funds and does not
19 anticipate receiving additional funds, thereby eliminating the need for the Housing Advisory
20 Board; and

21
22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County to repeal Chapter 148A in its entirety.

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

28 SECTION 1

30 Chapter 148A of the Codified Ordinances of the County of Summit, entitled "Housing
31 Advisory Board," is hereby repealed in its entirety.

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason of immediately
37 repealing Chapter 148A to dissolve the Housing Advisory Board due to the lack of necessary
38 funds.

40 SECTION 3

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

46 SECTION 4

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
51 were in meetings open to the public, in compliance with all legal requirements, including Section
52 121.22 of the Ohio Revised Code.
