7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for grants received by the County**
9 **Executive's Department of Job and Family Services during State Fiscal Years 2014-2015**
10 **(7/1/13 through 6/30/15), for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
14 that the Ohio Department of Job and Family Services may only make grants to counties through
15 subgrant agreements as described in that Section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
18 Department of Job and Family Services developed a standard subgrant agreement to be executed
19 by the Executive or commissioners of each county prior to receiving Department of Job and
20 Family Services grant funds; and

22 WHEREAS, the County of Summit Department of Job and Family Services has received
23 from the Ohio Department of Job and Family Services the standard subgrant agreement for State
24 Fiscal Years ("SFY") 2014-2015 (7/1/13 through 6/30/15) that sets forth the rights and
25 responsibilities of both the Ohio Department of Job and Family Services and the County
26 Executive's Department of Job and Family Services in relation to any grant that is awarded for
27 SFY 2014-2015; and

29 WHEREAS, the County of Summit Department of Job and Family Services anticipates
30 receiving grant funds from the Ohio Department of Job and Family Services for SFY 2014-2015;

33 WHEREAS, this Council has determined by reviewing all pertinent information that it is
34 necessary and in the best interest of the County of Summit to authorize the County Executive to
35 execute said subgrant agreement for SFY 2014-2015.

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 The County Executive is hereby authorized to execute a subgrant agreement with the
43 Ohio Department of Job and Family Services for grants received by the County Executive's

SECTION 2
