7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Gable Elevator for a five-year elevator maintenance agreement for the elevators located in**
9 **the Summit County Parking Deck, in Council District 4, in an amount not to exceed**
10 **\$62,447.00, for the Executive's Department of Administrative Services – Physical Plants,**
11 **and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 1, 2013, awarded a purchase
14 contract with Gable Elevator for a five-year elevator maintenance agreement for the elevators
15 located in the Summit County Parking Deck, in Council District 4, subject to confirmation by
16 County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with Gable Elevator for a five-
27 year elevator maintenance agreement for the elevators located in the Summit County Parking
28 Deck, in Council District 4, in an amount not to exceed \$62,447.00, is hereby confirmed and the
29 County Executive is hereby authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the elevator maintenance agreement in 2013.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.


