7 **A Resolution increasing the 2013 Prosecutor’s SBC Inmate Phone Commission Fund**  
8 **operating budget, and the Employee Benefits appropriation within the budget, in the**  
9 **amount of \$9,000.00, for the fiscal year ending 12/31/13, for the Prosecutor, and declaring**  
10 **an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2012-475, which approved  
13 and appropriated the 2013 operating budget for the County of Summit, which included  
14 appropriations for the Prosecutor’s SBC Inmate Phone Commission Fund, for the fiscal year  
15 ending 12/31/13; and

17 WHEREAS, due to a change in employee medical insurance election for 2013, a shortage  
18 exists within the Prosecutor’s SBC Inmate Phone Commission Fund employee benefits  
19 appropriations; and

21 WHEREAS, it is necessary to increase the operating budget by \$9,000.00 in current  
22 employee benefits appropriations in order to provide adequate funding; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that the aforementioned increase and adjustment of the existing appropriation is necessary and in  
26 the best interest of the County of Summit;

8 effect and be in force at the earliest time provided by law.


