7 **A Resolution amending Resolution No. 2010-194 to increase the yearly amount of a**
8 **lease/purchase to \$101,630.50 per year for a five-year period, totaling \$508,152.50, on the**
9 **lease/purchase with Jack Doheny Supplies Ohio, Inc., with financing provided by Key**
10 **Government Financing, Inc., for two vehicle-mounted Vactor sewer cleaning combination**
11 **machines, for the Executive's Department of Environmental Services, and declaring an**
12 **emergency.**

13
14 WHEREAS, this Council previously adopted Resolution No. 2010-194, which approved
15 the lease/purchase for two vehicle-mounted Vactor sewer cleaning combination machines for a
16 five-year period, under State Term Pricing, in the amount of \$100,504.22 per year, for a total
17 amount not to exceed \$502,521.10; and

18
19 WHEREAS, due to an error in calculation, the yearly lease amount authorized in
20 Resolution No. 2010-194 was not correct, and should actually be \$101,630.50 per year, for a
21 total not to exceed \$508,152.50 for the five-year period; and

23 WHEREAS, it is necessary to amend Resolution No. 2010-194 to correct the yearly and
24 total amounts approved in Resolution No. 2010-194 to reflect the true amounts due under the
25 lease/purchase; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information
28 that it is necessary and in the best interest of the County of Summit to amend Section 923.01(b)
29 for the aforementioned purpose;

31 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
32 of Ohio, that:

36 Resolution No. 2010-194 is hereby amended to reflect that the yearly amount of the
37 lease/purchase authorized therein shall be \$101,630.50 per year for a five-year period, totaling
38 \$508,152.50, on the lease/purchase with Jack Doheny Supplies Ohio, Inc., with financing
39 provided by Key Government Financing, Inc., for two vehicle-mounted Vactor sewer cleaning
40 combination machines.

44 This Resolution is hereby declared an emergency in the interest of the health safety and
45 welfare of the citizens of the County of Summit and for the further reason that it is necessary to
46 immediately amend Resolution No. 2010-194 to correct a mathematical error so that proper
47 payment may be made.
