7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**
8 **professional service contract with Akron Community Service Center and Urban League,**
9 **Inc., for the Next Step Youth Employment Service Center, for the period 7/1/13 through**
10 **6/30/14, in an amount not to exceed \$360,000.00, for the Executive's Department of Job and**
11 **Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 29, 2013, awarded a renewal
14 (first of two) of a professional service contract with Akron Community Service Center and
15 Urban League, Inc., for the Next Step Youth Employment Service Center, for the period 7/1/13
16 through 6/30/14, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a renewal (first of two) of a professional service
27 contract with Akron Community Service Center and Urban League, Inc., for the Next Step
28 Youth Employment Service Center, for the period 7/1/13 through 6/30/14, in an amount not to
29 exceed \$360,000.00, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide Next Step services effective 7/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,


