7 **A Resolution confirming an award by the Board of Control of professional service**  
8 **contracts with various providers per attached Exhibit A, for ex-offender employment**  
9 **services, for the period 7/1/13 through 6/30/14, with two options to renew for an additional**  
10 **one-year term, in a total amount not to exceed \$330,193.00., for the Executive's**  
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 29, 2013, awarded  
14 professional service contracts with various providers per attached Exhibit A, for ex-offender  
15 employment services, for the period 7/1/13 through 6/30/14, with two options to renew for an  
16 additional one-year term, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contracts are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of professional service contracts with various  
27 providers per attached Exhibit A, for ex-offender employment services, for the period 7/1/13  
28 through 6/30/14, with two options to renew for an additional one-year term, in a total amount not  
29 to exceed \$330,193.00, is hereby confirmed and the County Executive is hereby authorized to  
30 execute such contracts.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for ex-offender employment services effective 7/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
