7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with various providers per attached Exhibit A, for youth employment and**
9 **educational services, for the period 7/1/13 through 6/30/14, with two options to renew for**
10 **an additional one-year term, in a total amount not to exceed \$786,063.00, for the**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 29, 2013, awarded
14 professional service contracts with various providers per attached Exhibit A, for youth
15 employment and educational services, for the period 7/1/13 through 6/30/14, with two options to
16 renew for an additional one-year term, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contracts are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of professional service contracts with various
27 providers per attached Exhibit A, for youth employment and educational services, for the period
28 7/1/13 through 6/30/14, with two options to renew for an additional one-year term, in a total
29 amount not to exceed \$786,063.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contracts.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for youth employment and educational services effective 7/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
